Oceanside's Community Partners:

1. Our Affiliations: (a general idea of per case compensation is included)
 - a. We currently have contracts with and regularly get referrals from:
 - i. Private Referrals/Family/Physician referrals: These are our "bread and butter" cases seen in the office by Dr. VanSkiver - traditional LD/ASD/ADHD type cases where we want to help understand learning needs and interventions for the kid. These are mostly private pay cases. Tricare is the only insurance we are in network with.
 - ii. Newport News Behavioral Health - residential facility in Newport News
 1. Population is largely trauma based and foster care. We work with them on "diagnostic clarity" and help them integrate a child's history, testing results, and presentation with intervention needs in both the facility and upon discharge, in the community. Trauma-informed Assessment a must.
 - iii. St. Mary's Home for Disabled Children in Norfolk
 1. Complex medical/comorbid ID/DD long-term care facility. We use the DP-4 to provide psych updates to the schools and the community to ensure the child is still eligible for services
 - iv. Barry Robinson Center - a military-family based residential facility in Norfolk
 1. Population is largely ASD rule-out, military trauma, and complex family dynamics. We LOVE trauma-informed and creative collaboration on ASD assessments here. Therapists are amazing partners in diagnosis.
 - v. Evidence-Based Associates (EBA- Youth Court-Ordered evaluations)
 1. Juvenile Justice involved kids, high trauma, lots incarcerated. We work from a trauma-informed perspective to help stakeholders understand why the child is struggling and what treatment services may be needed to help them succeed.
 2. We also may partner with them to look at undiagnosed reading/cognitive issues and correlation with criminal behavior/school to prison pipeline
 - vi. Independent Educational Evaluations (IEEs):
 1. We strive to take cases where we can be helpful and not contentious. If a case is going to due process, we generally will happily take it, but we try to do so only outside WJCC/York as we're trying to maintain good relationships with our districts

- vii. Colonial Behavioral Health, Departments of Social Services and other such agencies often have kids they need tested quickly and they refer them to us.

- b. William and Mary:
 - i. William and Mary Law School, Pele Clinic: Dr. VanSkiver serves as a regular consultant, guest lecturer, and co-presenter at ISEA, and at the Law School on the topic of educational and psychological testing and the intersection with special education. Advocacy is one of our passions, and we are so privileged to work with the Law School.
 - ii. William and Mary School of Education, Educational Specialist Program: We are currently partnering with W&M to build a training program/site for their students that will allow us to serve more of the community We are in Phase 1 of 3 Phases and having so much fun!
